Exceptions may be granted by the Board for a specific time and purpose. A verifiable primary residence must be maintained for the full term of the lease agreement.

Lease sites 321 - 330, the maximum total RV length is 31 feet due to the size of the site. All other lease sites are subject to maximum 40' total length of RV.

RV's will be parked parallel to existing units with the back of the unit, including slide outs, even or in front of a visual alignment with the utility posts and providing 1 meter clearance from the front of the electrical panel to the closest part of the RV.

Decks or other additions will be subject to the NBPC construction policy and will require a NBPC Construction Application with Board approval prior to the start of construction. *Applications for standalone storage sheds and fencing (permanent or temporary) will not be approved.*

All standard camp policies i.e.: Pet Policy, Policies & Guidelines, will be adhered to.

NOTE: The term of a site Lease at Nanoose Bay Pentecostal Camp is from January to December each year. Should you apply for a site, your lease begins from the time of approval by the Board of Nanoose Bay Pentecostal Camp until December 31st of that same year.
