

NANOOSE BAY PENTECOSTAL CAMP GOLF CART POLICY

In order to ensure a safe and enjoyable stay for all, anyone bringing a Golf Cart onto the campgrounds is required to Complete and comply with the following requirements & guidelines (camp staff excluded):

- ❖ Anyone, including Leaseholders, bringing a Golf Cart onto the campgrounds must complete a registration form and provide it to the Camp Office for approval PRIOR to its delivery. Delivery will be refused if Golf Cart registration has not been received by the Camp Office.
- ❖ Golf carts are to be operated by a responsible adult. No operators under the age of 18 are permitted.
- ❖ Golf Carts must use the roadways on the campground only and keep to a low speed at all times.
- ❖ **Golf Carts may NOT travel through playgrounds, open areas or fields to access the roadways or any other buildings on the campground.** (Any exceptions for mobility issues will require staff approval.)
- ❖ Golf Carts must be parked in areas designated for Golf Carts only.
- ❖ Violation of the Golf Cart Policy will result in users being asked to remove the Golf Cart immediately from the camp grounds. If users of Golf Carts disregard these guidelines repeatedly, they will be banned from bringing a Golf Cart to the campgrounds.

The camp board has put significant thought and effort into accommodating the needs of persons with mobility issues. Your cooperation will make it possible to ensure that Golf Carts will continue to be allowed on the campground. If information or registration forms are required, please contact the Camp office or check on the camp Website. **Camp Staff are the exception to this and are able to use golf carts anywhere on the grounds.*

The Guest does hereby indemnify, agree to defend, and hold Nanoose Bay Pentecostal Camp harmless from any and all loss, damage, or injury to any person or persons whosoever, or property, arising from any cause or reason whatsoever in or about the Nanoose Bay Pentecostal Camp grounds of the described facilities; and the Guest further agrees to waive all the claims against the Nanoose Bay Pentecostal Camp on account of any loss, damage, or injury from whatever cause which may occur to it on its property in the use and occupancy of the Nanoose Bay Pentecostal Camp premises; and the Guest agrees to promptly and upon demand, reimburse Nanoose Bay Pentecostal Camp for any damage done to the Camp premises or equipment, and for equipment lost or stolen by the Guest or anyone attending its activities.
